





2. REGSITERED OFFICE:- The registered office of the Trust shall be situated at Balbhadrapur, P.O. Laheriasarai, Dist. Darbhanga, Bihar.

3. DECLARATION OF THE TRUST AND ITS OBJECTIVES :-

To maintain, contribute or to give aid to any existing medical, technical, professional academic or social institutions or any charitable institution with philanthropic purpose which may be in the general interest of the poor people of Muslim Minority Community and to do all such acts and things with the objects of giving relief to the poor and backward people of Muslim Minority Community.

During his life time, he may nominate any person as trustee and chairman of the Board of Trustees as his successor in office. The successor Trustee so nominated shall inter into the office of the Trustee and the Chairman after the life time of the present Chairman Dr. Sharique Hussain. The Treasurer Mozammil Hassan may also nominate during his life time his successor, trustee and the treasurer of the Board of Trustees. If the present Chairman or the Treasurer fail to nominate their successors during their life time in that event after their life time the remaining Trustees shall elect one amongst themselves as the Chairman or the Treasurer Board of Trustees as the may be and without prejudice to the generality of the objects and powers above mentioned, the trustees shall have to do all or any of the followings:-



The members of the governing body other than the ex-officio members shall hold Office of the members of the Governing Body till their lives and during their life time they may nominate their respective successors as the members of the governing body. The person or the persons so nominated shall inter into the office of the members of the governing body after the life time of their respective predecessor. If any member of the Governing body fails to nominate his successor during his life time in that event the remaining members shall co-opt any person or persons from the field of teacher education as member/members of the governing body. In no case the member of the governing body shall exceed more than seven including ex-officio members.

To invest and kept invested the Trust properties in the purchase of immovable properties or in other assets specified in section 11(5) of the income Tax Act 1961 and to alter vary and transpose such investment from time to time as the Trustees shall, in their absolute discretion, think fit. - iii. The Trustees may from time to time frame schemes, rules, regulations, laws and bye-laws for regulating the affairs of the project undertaken by the Trust in

10. RESTRICTION OR USE OF TRUST FUND AND DISPOSAL OF FUNDS ON DISSOLUTION :-


